# Terms and Conditions

#### Dates

Session 1: July 5 - July 18, 2026 Session 2: July 19 - August 1, 2026 Session 3: July 19 - August 9, 2026

Session O (Odyssey): August 2 - August 9, 2026 Stays of 4 or 5 weeks can be arranged on request

### Fee Structure

#### Fees include

- Transport for campers to and from Geneva airport (during the official arrival and departure dates)
- Morning lessons (English, French, Spanish, Public Speaking, or Entrepreneurship) - 15 hours / week from July 5 to August 1
- Accommodation (not for day camp)
- Full board
- Afternoon activities
- · Evening entertainment
- Laundry
- Health & Accident Insurance covering medical costs

# Fees do not include (non-exhaustive)

- Personal expenses
- Pocket money: CHF 150 / week (CHF 50 / week for Junior Campers)
- Transfers outside of the official arrival and departure dates
- Transfers to other airports or train stations
- Transfers for medical appointments
- Supplement for campers arriving / departing with UM service: 150 CHF / way
- Photo option:

Sessions 1, 2 or 3: 15 photos, CHF 300 Session O: 10 photos, CHF 200

#### Cost

For 2 weeks: CHF 8100 boarding / CHF 6150 day

(including CHF 1000 registration fee)

For 3 weeks (Session 2 plus Odyssey): CHF 11750 boarding / CHF 8875 day (including CHF 1000 registration fee)
For Odyssey (1 week): CHF 4380 boarding / CHF 3300 day

(including CHF 500 registration fee)

# Payment Deadlines

The registration fee is due at the moment of sign-up. The remaining camp fees are due by 15 March 2026. Registrations passed this date will require immediate payment of the full amount.

We reserve the right to cancel the registration if no payment is received.

Payment must be in CHF. The school does not accept cash payments.

#### Cancellation Policy

The registration fee of CHF 1000 (Sessions 1, 2 or 3) or of CHF 500 (Session O) is non-refundable.

Cancellation 60 days or more before the camp:

50% cancellation fee.

Cancellation 59 days or less before the camp:

100% cancellation fee.

The cancellation fee applies in all cases, including illness. Parents may wish to take out separate cancellation insurance to cover such events. In case of an early departure from the camp, no refund will be made. This includes health related early departures from the camp.

Any refund due will be made into the account from which funds were received.

The parents are responsible for the arrival and entry into Switzerland of campers. Securing a visa to allow entry to Switzerland, where necessary, is the responsibility of the parents. Beau Soleil Summer Camp declines any responsibility in case of late arrival due to a visa problem or any other necessary documents for entry into Switzerland.



#### Sanctioned countries and individuals

The school cannot accept payments from Crimea, Donetsk, Luhansk, Zaporizhzhia, and Kherson regions of Ukraine, as well as from Cuba, Iran, North Korea, Syria, or Venezuela. Parents must ensure that no payment originates from these countries and that the payment is not from a sanctioned bank account as per the US government's OFAC sanctions list or the Swiss government's SECO sanctions list. The school cannot accept payment from or on behalf of any individual on US, UK or Swiss sanctions lists.

#### Hazardous activities

While the camp takes all reasonable steps to keep campers safe, parents accept that there is some level of inherent risk in the range of activities provided by Beau Soleil. Information about activities and risk assessment is available from the camp by contacting summercamp@beausoleil.ch

## Responsibility for injury, damage, or loss

Beau Soleil Summer camp is not liable for accidents, injuries or damage to property suffered by campers, however so caused. Likewise, the camp cannot accept responsibility for accidents, injuries or damage to property caused by a camper to a third party. Campers are responsible for their own belongings while at summer camp. If lost items are found around school, the camp will make reasonable attempts to return them to their owner.

The school cannot accept any responsibility in the case of the loss or theft of money, jewellery, items of clothing and / or other valuable objects which have not been explicitly entrusted to the safe keeping of the school. Parents are jointly and severally liable for any damage caused by campers during the camp.

#### Behaviour and Conduct

Campers are expected to act responsibly and to follow the Summer Camp rules. Ongoing issues of behaviour will be reviewed by the Head of Summer Camp and may be referred to the Principal.

Severe or repeated breaches of camp rules, including but not limited to use of alcohol or drugs, may result in immediate expulsion from the camp, at the sole discretion of the Principal. In such a case no reimbursement will be made, and all fees are due to the school; parents will be required to arrange immediate supervision and collection of the camper.

#### Medical

Parents are required to complete the health form, which forms part of the terms and conditions for the Beau Soleil summer camp.

# Alterations to Programme

Beau Soleil Summer Camp offers a wide range of activities for the campers. The published programme is for guidance and changes might occur for logistic or meteorological reasons.

## Force Majeure

Beau Soleil Summer Camp can suspend or even stop, the courses and all other services, in particular the Camp, for reasons of force majeure, natural disasters (e.g. fire, floods, earthquakes, storms), explosions, epidemics, quarantines, sabotage, riots, civil unrest, strikes, war or any other similar circumstances affecting the sustainable operation of the holding of Beau Soleil Summer camp. In case of force majeure, the parents acknowledge that the inability to provide the services is not attributable to Beau Soleil so that Beau Soleil is not due to provide any reimbursement, even partial.

#### Personal data

We take all reasonable steps to comply with the Swiss Federal Act on Data Protection (Data Protection Act, FADP) in processing your personal data.

More specifically, we intend to draw your attention to the following important contractual terms:

 The school takes every reasonable step to rectify – and possibly erase – Personal Data that are inaccurate or obsolete, having regard to the purposes for which they are processed.



- Your undertaking: It is the responsibility of parents or guardians to ensure that accurate information is provided to the school and kept updated promptly when changes occur. This includes medical information, including allergies and medication, learning support needs, information about psychological or psychiatric treatment, information about family circumstances that may impact the student's welfare or education.
- Your consent: by enrolling your child / children with us, you, as parents, hereby consent to our use of your child / children photo, video footage, name or work from the school. See our dedicated contractual Students' Image Flyer, which forms part of these terms and conditions, for further information as to the context and scope of your consent and the option to withdraw the same.
- The school may place a student's photo, video footage, name or work from the school on its affiliated websites, social media, marketing materials, corporate communications (including annual reports) or publications.

#### Applicable law and jurisdiction

Swiss legislation alone is competent to arbitrate any litigation arising from the present contract, regardless of the parents' place of residence or that of a titular bearer of parental authority. Any difficulty arising from the present contract will be settled by the legislation of Canton de Vaud within the Aigle judicial district. The school reserves the right to make changes to the programme, the pricing, and the terms & conditions.
